

This is to address the notice from Michael Trigger Wilson.

On May 30th 2026 the Nevada Assembly People addressed the notice from Michael Trigger Wilson. With the first response being, The Nevada Assembly has never voted, or confirmed Michael Trigger Wilson as any representative of The Nevada Assembly. This response to Michael Trigger Wilson is to inform him to cease and desist anymore notices, or try to represent The Nevada Assembly without the Authority of the People in Nevada.

Now, in response to the notice that Michael Trigger Wilson has sent to William Rockie Roper.

1. Please be aware, we shall never use all capital letters in representation of The Nevada Assembly name. Nevada Assembly is not a corporation and does not stand in that jurisdiction.
2. Michael Wilson's notice is operating in multiple jurisdictions with upper case; **UCC - UNIFORM COMMERCIAL CODE - MUNICIPAL and upper/lower; CMJ - Uniform Code of Military Justice - Territorial**. Again, representing more than one jurisdiction.
3. Sue Hulsebus and Michael Trigger Wilson are ordered now to stop conducting secret meetings with the conduction of votes and notices without the Peoples written approval of any changes to The Nevada Assembly. This is also a demand for all recordings, video and audio, of any State meetings to be handed over to the People of the assembly by June 30th of 2026. 4. The People of Nevada are requesting for Michael Trigger Wilson to have more training before he becomes a Militia Commander. Attached is the portion of the "How to build an Assembly Section 14" for Militia assembly guidelines.
5. The domain name @thenevadaunionstategov.land was voted in by the People of the assembly. March 23 2026 the new domain started to be used to represent The Union State and the recording secretaries of the State and their counties.
6. There is only one Union State Assembly and William Rockie Roper is the Coordinator of that assembly and the People of The Union State are requesting for Michael Trigger Wilson and The Nevada Assembly to stop holding Union State meetings. The meetings are held by William Rockie Roper and having two assemblies working on it will only confuse the people even more.
7. Michael Trigger Wilson keeps referencing the Washington States' Land Recording Office as a Federation Land Recording Office. There is no Federation Land Recording Office and Teri Sahn is not our Federation Land Recording Office Coordinator. The people in the Nevada Assembly voted on this on May 30 2026.
8. In all Nevada State Assembly meetings, they keep referencing County Coordinators as County Facilitators, this needs to stop. As Anna has addressed this many times in the Coordinator training calls that all County and State Coordinators are Federation approved and vetted by the Continental Marshalls or the Federation themselves. Anna says the states are using the words facilitators or organizers to represent the coordinators in the counties and they are not any of those, they are Coordinators.
9. Michael Trigger Wilson keeps referring to his dual citizen because he has done is paperwork. This is one more reason why he can't hold the office of Militia Commander.

This is to address the notice from Michael Trigger Wilson.

10. Section I. - Michael Trigger Wilson's notice states that the Militia Commander has some kind of authority over the People or The Nevada Assembly, which he does not have any authority. The authority lies with the People of the Assembly. (Referenced in The Nevada Business Assembly meeting June 2026 as Michael Trigger Wilson(speaker one) has stated himself, 16 minutes 29 seconds, we the sovereign, self governing people, are the ultimate authority. 2nd reference, there's no authority above that of the people 33 minutes 29 seconds)
11. Section II A. The statement of facts that Michael Trigger Wilson has referenced in his notice, has been addressed with the People of the Assembly. On May 30th 2026 the People of the Nevada Assembly have voted to give William Rockie Roper, the right to purchase and distribute the Nevada seals, stamps, embossers, foil seals to the recording secretaries. (State meeting minutes are attached)
12. Section II. B – This has also been addressed with the People of the Nevada Assembly. May 30 2026 all four of the people who Michael Trigger Wilson mentioned were voted in to be recording secretary for The Nevada Assembly with the addition of a 5th recording secretary voted in by the People also, William Rockie Roper. (See the minutes of the meeting attached).
13. Section III. 1 – This has also been addressed with the People of the Nevada Assembly, and a vote was taken on May 30th of 2026 which resulted in William Rockie Roper and the recording secretaries being able to use The Nevada Assembly seal or logo in their work with The Nevada Assembly business.
14. Section III. 2 – Please correct your records, as there were six individuals named in the notice and than there were only four recording secretaries named. The People of The Nevada Assembly voted on May 30th of 2026 to recognize the four People of The Nevada Assembly as recording secretaries, and voted in a fifth William Rockie Roper. The Nevada Assembly does not have a Land Recording Office Coordinator. If Michael Trigger Wilson was correctly trained, he would have known that we only have a chair of the recording secretary committee.
15. Section IV – This document shall serve as a response to Michael Trigger Wilson, who has no authority over The Nevada Assembly, it is the People who have the authority to determine how The Nevada Assembly operates and functions. Please see attached cited material within this document.

This is to address the notice from Michael Trigger Wilson.
